Canby Alliance Church Minutes of the Annual Vision Meeting September 8, 2024

1. Welcome and Opening

During the Sunday Service the Annual Business Meeting was opened by Pastor Joshua at 9:45am.

2. New Members, Roll Call and Quorum

- **b.** Pastor Joshua took roll call from the list of CAC active members. Those in attendance were tabulated.
- **c.** Dan Lundy, secretary, confirmed that there was a quorum (94 of 165 active members) in attendance to discuss business. (List of attendees attached)

3. September 8, 2024 Agenda and February 4, 2024 Minutes

- **a.** Pastor Joshua confirmed with all present that there were no objections to the Agenda:
 - i. Approval of the 2/24 Minutes
 - ii. Approval of the Fiscal Year (July 2024 June 2025) Budget
 - **iii.** Election of Financial Secretary (Current elected officers to continue to serve until September 2025).
- **b.** Will Greenleaf moved that the February 4, 2024 Minutes be approved, Steve Chinn seconded, and approved.

4. Fiscal Year 2025 Budget

- a. Elder Board Chair Mel Yamase provided comments related to the budget:
 - i. The church received a one-time gift of \$100,000 in 2023.
 - **ii.** This gift, along with our existing reserve will provide for three years of Senior Pastor salary.
 - iii. The Elder Board has chosen to take the faith filled risk of hiring a Senior Pastor. We do this anticipating that our church will grow along with increased giving.
- **b.** Pastor Joshua noted the budget under consideration does not include the salary package for a senior pastor. An amended budget that includes the Senior Pastor compensation will need to be approved by another church business meeting. Questions or comments were invited from the floor. Hearing none, he invited a motion.
- c. Jeff Robison moved to approve the budget, Ann Liday seconded, approved.

5. Election of Financial Secretary

- a. Eileen Swigert has been serving as our interim financial secretary for several months. The Nominating Committee has nominated Eileen Swigert to the office of Financial Secretary for a 1-year term (Nominating Committee report attached). With no nominations from the floor, the nominations were closed.
- **b.** Pastor Joshua moved that the ballot be waived, and the nominee be elected by unanimous consent, Steve Chinn seconded. By unanimous consent, Eileen Swigert is elected as the church Financial Secretary.

Report of the Lead Pastor Ryan Doughty

As we wrap up this school year, it's clear that God is moving in big ways in our youth ministry. From major events to powerful moments of transformation, it's been a season full of growth, connection, and momentum. Here's a look at some of the highlights.

• 34 Dinners Served (and Counting!)

A huge thank-you to our church family and volunteers who've helped serve 34 dinners this year. These nights continue to be about more than just food—they're a space where relationships grow, conversations go deeper, and students feel known and cared for.

• DARUDE 2025 – Our Biggest Yet

In February, we took 31 people to our annual beach retreat, DARUDE—including 26 students, making it our most attended retreat ever. The weekend was packed with worship, teaching, laughter, late-night talks, and real-life transformation. DARUDE continues to be a defining experience in the life of our ministry.

• Yuletide Spectacular

December brought the return of the Yuletide Spectacular, and it lived up to its name. Just over 100 students showed up to celebrate, connect, and experience the joy of the season together. It was a high-energy, high-impact night we won't forget.

• Two Students Baptized

One of the most powerful moments of the year happened this spring when we celebrated the baptisms of two of our students. Watching them publicly declare their faith in Jesus was a huge reminder of why we do what we do.

• Looking Ahead

As we head into a new year, we're stepping forward with fresh vision. We're starting strong with a full youth staff, preparing to launch a student leadership team, and doubling down on our commitment to reach students who don't yet know Jesus. The future is full of opportunity, and we can't wait to see what God has in store.

Thank you to every parent, volunteer, and leader who has walked with us this year. Special thanks to our Youth Team: Nicolle, Lindsey, Kasey, Rachel, Adam, Silas, Josiah, Adam, and Tommy. Your time, energy, and support are what make this ministry possible. Let's keep building together.

In His Service, Nick, In Children's Ministry, transformation can be seen in children, their families and the volunteers who work for them.

<u>Blaze (3rd-5th graders)</u> met on Wednesdays during the school year, with free time play in the Great Hall and a bible lesson, activities, or crafts to emphasize the biblical truth using classrooms in the upstairs Children's Wing. Blaze joined the middle school and high school for dinners in the gym.

Our typical attendance was 7 students, with a high of 11. Our students have prayed for friends, invited friends, and some friends have become part of our group.

<u>Embers (ages 1-4)</u> and <u>Sparks (elementary)</u> classes serve the whole family with age-appropriate, biblically focused activities and lessons during the Sunday morning service. Volunteers give up their time in the service to build relationships with kids and learn together about God.

<u>CREATE theatre camp (3rd-7th graders)</u> included 47 kids for a week of half-day camp, sharing biblical stories from the life of Peter and performing children's stories connected to the theme of journeying with Jesus. 32+ volunteers helped with things from picking up cardboard to teaching lessons and working with a group of kids all week. Celebrations of flexibility, bravery, and growth were witnessed on Friday by about 100 audience members.

Additional CAC Ministries 2025

Report of the Facilities Manager Alan Rudy

Our facility is used every day by different groups for a variety of events. In September 2024, the "Classical Conversations" home school group began their sixth year using our facility. As with last year, they have morning and afternoon classes from grades K-12. Our entire Children's Wing and several classrooms downstairs are used every Monday from 8:00-4:30. The contract is from September to the end of April. They respect our facility, and do their best to clean up, which is helpful and appreciated. We have also had three large memorial services this past year. One last November, another in December, and the most recent in February. All were long-time Canby Alliance attenders. Working with the families to make it comfortable for those in attendance is a core mission. Working with the groups by communicating, assisting with accommodations and set-up. I enjoy getting to know more people in our community.

This year we moved our conference room from the main office to upstairs in the Children's Wing. It is a much quieter room, and better suited for board and elder meetings, as well as numerous bible studies. Weekly scheduled events include Men's and Women's bible studies, ladies and Solo Sister's events, MOMS Club, TOPS, basketball (youth and adult), middle and high school youth groups. We have CAC families who use our gym for gatherings in both spring and fall. We had an all-church Christmas decorating party last December. It was so nice to see people of all ages from CAC participate. In addition, the SDA church continues to use our gym facility all day on Saturday for services.

Our Children's Ministry is 5-star as Rachel Keen has weekly kids events (Blaze) and theatre camp for a week in July. Operation Christmas Child continues to use our facility the entire 3rd week of November. It gets better and bigger each year. Our community "Willamette Valley Big Band" concert was held in the Sanctuary December 2024 and will be back in May 2025. We first hosted this group in May 2024.

In March 2025, Robert's Lighting retrofitted the entire gym with new energy efficient lighting. This new modern lighting technology eliminates all the ballasts and are "direct wire" with about half the energy used from the old lighting. We also used new, much stronger cages to protect from damage .

For several years, Dale Johnson from Roth heating has maintained the units on all 3 floors, roof, attic and outside. Keeping them working properly with bi-annual preventive maintenance in April and October to get the most out of our long-term investment. I monitor and am proactive daily in all the operations of our mechanical systems. I have re-negotiated our contract to cut down on the cost. Our passenger elevators are serviced every 3 months for correct operations.

Regular roof cleaning, moss treatment, and maintenance, daily security walkarounds, and being a visual and familiar presence are essential. As in previous years, several neighbors use our parking lot for their cars and trucks during the week. We have an official vehicle registration form that was approved by the Admin Board so we know who is using our parking lot.

Doug Beck and I communicate about the building needs and proposals. He is great to work with. I am very fortunate to have such supportive Elders and Admin Board members that listen to my vision for keeping our facility looking and functioning efficiently. I am available however needed. Being aware of our surroundings is vital to the mission. I am proactive with security inside and out. The cleanliness of our facility, repairs, energy efficiency and "ownership" is deep in my heart for all of it. I am very thankful for living close by. A big thank you to my also co-workers. The hope is to always have each other's back.

May The Lord Jesus Christ be praised. I pray for all of us to have a bent heart and not just a bent knee to The One that has each of our names written on His nail pierced hands and feet.

Report of the Deaconesses Sandi Beck, Chair

The deaconesses, and those that come alongside them, serve as the hospitality and heart at Canby Alliance Church. With a broad stroke, their service touches many by providing meals, delivering cards and flowers, managing the kitchen, laundering tablecloths and towels, preparing communion and serving refreshments and/or food at services and events.

The deaconesses tenderly served our church family in many ways this year. They delivered more than eighty meals to those incapacitated through injury, illness, or surgery. They delivered at least thirty-nine cards, flowers or small gifts to family members celebrating a new baby, recovering from injury or surgery or grieving the loss of a loved one. They provided refreshments or food and/or served in set-up and cleanup for the following events: Memorial for Gary Marshall, Big Band Concert, Neighborhood Alliance Outreach, Dave Gordon Memorial, Ryan Doughty's Candidate Visit, John Vaudt Memorial, Pastor Ryan's Installation Service, Diana Stewart Memorial, and the Joshua Stager Farewell Service.

Canby Alliance is loved and served well by our deaconesses and those who provide extra help. They give of their time sacrificially and generously and it is a joy to see them in action. I am grateful to have had the opportunity to learn from them and imitate their ways. Jesus is evident in their lives, in their hands and in their feet as they use their talents to benefit our church family.

Dear Church Family,

As we reflect on the past months, we are filled with gratitude for the many ways God continues to provide for and sustain our church community. The Trustees Board is thankful for your ongoing support, prayers, and involvement as we work to maintain and improve the spaces where we gather, worship, and serve. Below is an update on recent and ongoing projects.

Prayer Room Maintenance

We are blessed to have a dedicated Prayer Room for our church family—a sacred space for reflection and intercession. The room needed a fresh coat of paint, and was set up with new prayer stations. Thanks to the many volunteers who helped design and implement the room.

Kitchen Equipment Update

Our church kitchen is a hub of fellowship and hospitality. Recently, we discovered that the lower oven was not heating properly. The ovens were repaired and are now functioning normally.

Gym Lighting Upgrade

Thanks to the Admin Board's approval in February, we've upgraded the gym lights. The project involved replacing outdated ballasts with energy-efficient LED fixtures and installing new protective cages. The \$8,000 budget includes a \$1,000 energy rebate from Canby Electric.

Back Parking Lot Lighting

A special thank you to Steve Chinn, who discovered that the back parking lot lights had reset due to a power issue. He quickly reset the timer, and we're pleased to report that the lights are now functioning properly. These seemingly small fixes make a big difference in safety and accessibility.

Looking ahead

God has blessed our body with an amazing facility to carry out his work in Canby. Stewarding that resource well calls for us to care for the ongoing maintenance of the facility. In 2025-2026, \$47,000 is needed for special projects that are essential for the preservation and stewardship of our facility.

Children's Wing Roofing Project (\$22,000)

Planning is underway for re-roofing the Children's Wing. This area is vital to our ministry, and we want to ensure it remains a safe and welcoming place for our youngest members. More details will be shared as plans are finalized.

Sandblasting the Children's Wing Stairs (\$5,000)

Planning is also underway to sandblast and repaint the Children's Wing stairs. This is an essential step in the maintenance and care of that entrance in the event of an emergency.

Parking Lot Repair (\$20,000)

We are also planning on repairing the church parking lot and seal coating the area. This will help to preserve our parking lot and ensure accessibility. The approximate cost for this project is \$20,000.

Report of Men's Ministry Will Greenleaf, Pastor Ryan Doughty

At CAC, we have a growing passion of helping men apprentice the way of Jesus in every area of life. As we look back on this past year, there is much to celebrate!

First of all, we are seeing men connect in greater and deeper ways. The Men's Ministry monthly breakfast has grown to an average of 15 men. Starting First Fridays each month has allowed men to connect in a deeper way around a campfire.

Men are also growing in discipleship and the Word. Two men's Bible studies- Wednesday mornings led by Chris Payne and Thursday morning "Grey Hairs" led by Jim Hartle- are helping men dive more deeply into God's word. In addition, Pastor Ryan has started a lunch gathering on Fridays to help men grow more deeply in the practice and experience of prayer.

Will Greenleaf and Pastor Ryan are building a Men's Ministry team to foster fellowship, mentorship, community connection, and to brainstorm events/retreats.

We look forward to seeing what God will do among the men of CAC in the year ahead!!

Report of Women's Ministry Marilyn Greenleaf

This past year CAC Women's Ministry grew in ladies stepping up to lead in four areas: Christmas/Holiday events, Spring Events (teas, outing,), Retreat for CAC Ladies and Ladies Bible study/small groups. Sara Minson led our successful Christmas event which also included the women of the SDA Church, who meet in our building on Saturdays. The Women's Prayer Team led a well-attended Women's Prayer Retreat. Bette Vaudt and Joanna Crumley led the CAC Ladies Spring Tea in April. Others held small groups, invited people to their home for meals, shared baked goods, and visited the sick.

The Women's Prayer Team is often a behind-the-scenes team of women who PRAY. It is an honor to pray for CAC and for all who call this their "home."

Our main focus is to help establish a culture of prayer at CAC. Team members take turns praying after the morning worship service, and pray both privately and together for the requests (both confidential and general) that come to our team. We also pray together monthly on Zoom. We have had close to 100 prayer requests since January 2025. We have seen God intervene, heal, strengthen, soften hearts, comfort, bring help, be present in grief and loss, encourage, restore and more.

A few months ago, we visited the Arise Alliance Church in Hillsboro to see and experience their Prayer Room. This inspired us to think of ways we could duplicate what we experienced in our own Prayer Room at CAC. With the support of the elders and Pastor Ryan, we have refreshed the Prayer Room with interactive stations to help guide one's private prayer experience. We hope many will be inspired to visit the space and to pray.

Our team also planned a half-day, "Prayer 101" Women's Retreat in February and had 55 women sign up to attend. We are in the process of planning a follow-up retreat in October, "Prayer 102".
